Re: Request for Access under the *Freedom of Information and Protection of Privacy Act* ("FIPPA")

On Thursday August 30, 2018, St. Joseph's Healthcare Hamilton ("SJHH") received your request for access to information under the Freedom of Information and Protection of Privacy Act. You requested access to the following:

"All information on any medical treatment (ER/surgery/doctor's visit/etc.) provided by all affiliated SJHH hospitals and clinics as a result of any injuries and associated incidents that occurred at David Braley Athletic Centre of McMaster University dated from January 1, 2007 and until present.

To be included into the requested records:

- a) Date of injury/incident
- b) Type of injury/incident
- c) Location of injury/incident
- d) Type of treatment/department
- e) Short narrative for injury/treatment

Any type of personal information protected under FIPPA is NOT requested."

After conducting a thorough search for information responsive to your request, I can confirm that SJHH does not have the ability to retrieve or extract the requested data set. SJHH has consulted internally with our Health Information Services, Health Information Management, Finance, and Quality, Planning and Performance Improvement Departments who have confirmed this **specific data set not fully captured or retrievable in a manner which would allow us to satisfy your request**. As per FIPPA section 29(1)(a)(i), I am returning your request along with the \$5 application fee.
